# **BSST's Intervention**

#### **ADIP Scheme**

The main objective of the Assistance to Disabled persons for purchasing / fitting of aids / appliances (ADIP) scheme is to assist the needy disabled persons in procuring durable, sophisticated and scientifically manufactured, modern, standard aids and appliances that can promote their physical, social and psychological rehabilitation, by reducing the effects of disabilities and enhance their economic potential.

After implementing the ADIP scheme for 2 consecutive years the organization had got exposure of the procedure that needs to be followed for implementing the program. Hence, BSST has tried to keep all the necessary government departments in loop to reach out to maximum number of beneficiaries and benefit them from the scheme.

The details of the grant in aid received and beneficiaries by BSST under the ADIP Scheme from the Ministry of Social Justice and Empowerment are as follows:

The organization has its working team in these areas on various other projects and hence reaching out to find the beneficiaries was not very difficult for BSST. The identification of the beneficiaries was done by the team members of BSST by visiting the houses of the beneficiary followed by a thorough check up by professional doctors from the respective field.

#### **Child Helpline**

ChildLine is a Helpline No. 1098 wherein it provides support and guidance to the parents, children or relatives in distress due to issues related to children whether it be child labour, child trafficking or violence against children etc.

Brahma Samaj Seva Trust has been entrusted with this project on ChildLine by Ministry of Women and Child Development. BSST has conducted various activities for the generating

awareness about the helpline at the community level at small and large scale. The activities conducted are as below:

- 1. Awareness Generation Camp
- 2. Campaign against Child Labour
- 3. Awareness Campaign in Schools
- 4. Open House Discussion
- Liasioning with other concern departments

#### Health & Safety Training to Construction Workers

Health and Safety training was provided to construction workers to safeguard against



accidents. Gujarat Makan and Bandhkam Shramyogi Kalyan Board (Gujarat Housing and Construction Labourer Welfare Board) had prepared modules regarding Measures of Safety. Construction Workers are trained from prepared modules and workers are empanelled with related content that work becomes accurate and completed without any

health hazards. The training sessions were conducted in month of August 2017. Areas covered were Panchmahal, Mahisagar, Jamnagar, Junagadh, Morbi, Patan, Porbandar,

Banaskatha, Kheda and Dahod. The District Project Manager and State Project Officer of each location were notified about the same before conducting training.





The training included 3 hours of theory and 2 hours of practical. Total 50 labourers participated in this training session which was scheduled for a period of 5 days.

#### NABARD - MEDP

A separate, specific and focused skill building programme 'Micro Enterprise Development Programme (MEDP)' has been formulated which involves organizing short duration, location





specific programmes on skill upgradation / development for sustainable livelihoods / venturing micro-enterprises by matured SHG members. It is a supplemental effort to upgrade/ develop skill and preliminary business acumen of SHG members in order to enable them to cope up with the issues in relation to run a successful enterprise for income generation/ livelihood.

BSST provided MEDP training with the support of NABARD this year. Workshop for Artificial Jewellery making was held for SHG members of Vadali at Patan District and Chanasma, and Adiya in Harij District for 10 days in which 30 trainees were provided training. Stiching &

Sewing workshop were held for SHG members of Samarpur, Bhanavas and Nanakothasana at Satlasana District for 10 days in which 30 trainees were provided training. Guidance was also provided to trainees after the completion of program. A detailed half yearly report was provided twice during the year of training so as to access and monitor the progress of trainees.

# **HIV Programme**

It is critical to engage people in an effort to enhance understanding regarding unmet needs of population who are infected by HIV/AIDS. The main objective of BSST is to



people. The Project is implemented at Mehsana and Ahmedabad.

BSST carried out various activities which benefited 5000 people in Ahmedabad & 700 people in Mahesana. Major activities included World AIDS Day celebration which offered the key opportunity to increase the awareness among people, most possible

reduce new infections, comprehensive care, support & treatment to all people living with HIV/AIDS (PLHIV).

The effort is funded by **Gujarat state AIDS control society**, Ahmedabad and focuses on reduction stigma and discrimination attached with HIV infected



access to the treatment as well as discussing the preventive measures. Apart from Worlds Aids Day celebration campaigns were also held for inter personal behavior change communication (BCC), Promotion/ distributions of condoms, Provision of services for Sexually Transmitted Infections (STIs), Linkages to Integrated Counseling and Testing Services (ICTC), Advocacy for Enabling Environment.

This program reduces new infections, comprehensive care, support and treatment to all people living with HIV/AIDS.

### **Sanitation Campaign**

BSST raised awareness among public through this step by explaining that as long as people continues to defecate in open, everyone is at a risk of disease transmitted by faecal-oral route and water borne diseases. The main aim of this initiative is to promote hygiene education and sanitary awareness.

Construction of low cost toilets included hygiene, home sanitation, safe water, excreta & garbage disposal and waste water disposal in economical way, accepted by society. Organisation constructed low cost toilet units in municipal areas of Ahmedabad to protect and promote health of children and adults. This initiative is funded by Gujarat Municipal Finanace Board, Gandhinagar.

# **Participatory Irrigation Management**

Participatory Irrigation Management works for irrigational benefits like decrease in use of ground water, helps reducing water expense, reduce time spent on irrigation thereby resulting in net profit. PIM is a reform program working for the benefit of larger group of farmers collectively through sharing of water for irrigation.

BSST provides training and technical support after which outcome of training is monitored. In this a total of 1500 farmers got benefitted. Farmers are made responsible for adequate maintenance of irrigation system and economic utilisation of water for agricultural usage. PIM is funded by Sardar Sarovar Narmada Nigam LTD. Gandhinagar.



There is decrease in production cost of crops due to easy availability of water. The PIM project has been initiated and implemented in Patan district of Gujarat which is an arid region and normally receives much less rain compared to other districts of Gujarat.

## Other Programs from Our Corpus

• Blanket Distribution:- Blankets were distributed by BSST at Patan and Mehsana as a part of their initiative to rural people that helps them to sustain cold weather & climatic change.

Around 200 poor people got benefitted.

Village served:-Patan, Mehsana

 Uniform Distribution:- With the objective to promote educational aids among community specially a girl child, uniforms were provided by BSST.
 Around 350 people got benefitted.

Village served:- Mithighariyal, Chanasma Block, Patan.

• **Sweet Distribution:-** To spread happiness organisation distributes sweets among people of rural area.


Around 600 poor people got benefitted.
